Declarations of consent:

1. Information regarding data transfer to relevant sports federations and/or umbrella organizations:

I acknowledge that, in the event of participation in competitions, it may be necessary to transmit personal data to relevant sports federations and/or umbrella organizations in order to process these competitions. In addition, I agree that the data collected with this form may also be passed on to relevant sports federations for the purposes stated in the data privacy statement/information on the use of personal data. This consent may be revoked at any time with effect for the future by e-mail to info@viennametrostars.at, by letter to the registered office of the club, Ziegelhofstrasse 98/5, 1220 Vienna. I acknowledge that revoking the consent of the data transfer may lead to the exclusion from various events, competitions and also practice sessions/training camps or training courses, especially if these are events of the state/federal sports or umbrella federations.



I further acknowledge that in the event of a possible revocation the exercise of a competitive sport may be restricted, as the transfer of data is a prerequisite for this.

2. Using picture/photo/video recordings:

I hereby accept that during the exercise of the sport or during competitions photos and/or video recordings may be taken of me for the purpose of the public relations of the club, that they may be used for this purpose and published via live stream (transmission via the Internet at the time of the recording, no storage), via the Internet (available to anyone worldwide at any time) and in social media (Facebook – available to anyone worldwide at any time).

I do not derive any rights (e.g. remuneration) from this consent. This consent may be revoked at any time with effect for the future by e-mail to info@viennametrostars.at, by letter to the registered office of the club, Ziegelhofstrasse 98/5, 1220 Vienna. In case of a revocation, these recordings will be removed from the respective platform. If the recordings were available on the Internet, the removal will be effected to the best abilities of the club.

3. Information on the use of personal data/data privacy statement:

With my signature, I acknowledge that my personal data (first name, last name, if applicable first and last name of the parent(s)/legal guardian(s), date of birth, gender, address, ZIP Code, city/town, telephone number, e-mail address, date of joining, tariff class/category, possibly capacity) will be processed electronically and manually within the club on a contractual basis (membership). The purposes of the processing are: athletic, organizational and technical administration and financial processing, member administration, sending of club and federation information, information on events.

The club Wiener Baseball Softball Verein Vienna Metrostars is the controller for the processing activities described herein. Providing my data is required for fulfilling the purpose of the club pursuant to its statutes; if I do not provide the data, it is not possible to join the club.

The club will use personal data only for the purposes described herein. If the member leaves the club, all data will be deleted within one year of leaving the club at the latest, provided there is no arrears of payments on the part of the member, the data is not required for the assertion, exercise or defense of legal claims of the club and no longer storage of the data is required by law.



My data may be forwarded to relevant sports and umbrella federations if I have given my consent to the data being transmitted to them. The processing purposes of umbrella federations extend to the legal, fiscal and administrative support of the club, the organization of joint projects and events, the implementation of courses and further training, support and cooperation in the field of public relations and much more. The data processing at the level of relevant sports federations is directly related to the sport(s) I practice and ranges from administrative support for the club, the organization of events and competitions and direct cooperation with the individual club member to cooperation with national and international institutions and federations, especially regarding the exercise of competitive sports.

My rights in connection with data protection regulations extend to the right of access, to rectification, erasure, restriction, data portability and objection to processing. Furthermore, I have the right to lodge a complaint with the data protection authority – more details on all these issues can be found on the club's website under data protection (in German): www.viennametrostars.at.

4. Information about sports results management:

Based on the consent of the data subject pursuant to Art. 6 para. 1 (a) GDPR and/or the fulfillment of a contractual and/or legal obligation on the part of the controller pursuant to Art. 6 para. 1 (b) and (c) and/or (f) GDPR, the personal data of the data subject will be stored if they are required for the recording of performance/results and/or for results management in connection with registration for or participation in (athletic) events or competitions; they will also be stored and made publicly accessible pursuant to Art. 17 para. 3 in connection with Art. 89 GDPR for archival purposes in the public interest and the legitimate interests of the controller as well as stored and made publicly accessible by the Austrian Federal Sports Organization BSO, 1040 Vienna, Prinz-Eugen-Str. 12. The data subject expressly acknowledges this.
